### Department of Education, Federal Student Aid - Cybersecurity Operations Support

Zen supports Security Operations/Security Operations Center (SOC) efforts to protect, detect, respond, and recover from Information Security (IS) threats to FSA systems under their monitoring in accordance with EO 14028 and OMB M-21-31. Support includes proactive/reactive incident handling, security event management, forensics, vulnerability management, threat hunting audit/penetration testing, advising on proper security measures, encouraging industry best security practices, managing telephone trouble calls, issuance of Information System Security (ISS) Alerts, Advisories, Bulletins and ISS related information messages, intrusion detection and analysis support, forensics, digital media analysis and metrics reporting using ServiceNow.

## Department of Homeland Security, United States Customs and Immigration Services - Cyber Security Support Services (C3S) Architecture

Zen supports Zero Trust implementation and deployment in accordance with EO 14028 and OMB M-21-31 by designing, operating, and maintaining cybersecurity tools, reviewing source code, and assessing the security and effectiveness of systems. We also provide security architect expertise to other divisions, secure networks, operate the vulnerability management program, and develop and deploy solutions to automate security compliance systems hosted in cloud environments.

### Internal Revenue Service - Records Management and e-records Digitization

Zen provides records management expertise for transition to an Enterprise Electronic Records Management Framework and Approach that looks at People, Process, Technology, and Governance. This is the road-map for the IRS, Privacy, Governmental Liaison and Disclosure (PGLD), Records and Information Management (RIM) efforts for implementing and providing policies for existing capabilities in the IRS enterprise records management tools. Zen also provides Big Bucket scheduling, system reviews and training.
